- **3. Action Item:** Current Fiscal Statement/Invoices Presented for Payment: Commissioner Johnson inquired as to the \$32,798.70 payment to white Cloud. It was clarified that it was for the completion/installation of the of the new "SCADA" System Project.

Commissioner Bolduc made a motion to accept the minutes with correction requested, second by Commissioner Johnson, all in favor, motion carried.

A motion was made by Commissioner Johnson to amend the agenda, moving item 9, "Support 911 Saves Act" up next on the agenda. Second by Chief Hall, all in favor, motion passed.

9. Action Item: Approve Support for 911 Saves Act: Mike Mathews, Representative from Senator Jim Risch's Office: S.1175-911 Saves Act was presented to the JPB in request for support as it is being presented to the Senate asking that Public Safety Telecommunicator's be categorized as a protective service occupation under the Standard Occupational Classification System. It was noted by Chief Hall that the Police Chief's Association is in support of the bill and after a short discussion the board chose to also stand in support of the bill.

A motion was made by Chief Hall to support the Senate Bill S.4475 "911 Saves Act", second by Commissioner Johnson, all in favor, motion passed.
